This Cookie Policy explains what cookies are, what types of cookies we use on **www.divvly.app**, and how you can manage your cookie preferences.

1. What Are Cookies?

Cookies are small text files stored on your device (computer, tablet, smartphone) when you visit websites. Cookies are used to:

- Remember your preferences and settings
- Maintain your session after logging in
- Ensure security
- Analyze how you use the service
- Personalize content

2. Cookie Categories

We classify cookies into the following categories:

Category	Description	Consent
----------	-------------	---------

NECESSARY	Essential for the proper functioning of the website. The site cannot function properly without them.	Not required
PREFERENCES	Remember your settings and preferences (e.g., language).	Required
STATISTICS	Help us understand how users interact with the service (anonymous data).	Required
MARKETING	Used to display personalized advertisements.	Required

3. Cookies Used on Our Website

3.1. Necessary Cookies

These cookies are essential for the website to function and cannot be disabled.

Name	Provider	Purpose	Expiry
__Host-next-auth.csrf-token	www.divvly.app	Protection against CSRF (Cross-Site Request Forgery) attacks. Ensures the security of forms and requests.	Session
__Secure-next-auth.callback-url	www.divvly.app	Stores the redirect URL after login. Ensures proper authentication flow.	Session
CookieConsent	www.divvly.app	Stores your cookie consent preferences. Allows us to remember your choices.	1 year
nextauth.message	www.divvly.app	Handles authentication session communication. Essential for	Session

		proper login and session maintenance.	
next-auth.state	www.divvly.app	Stores OAuth state parameter for secure authentication flow. Prevents cross-site request forgery during social login.	Session
next-auth.nonce	www.divvly.app	Stores a unique nonce value for OpenID Connect authentication. Ensures the authentication response is valid and not replayed.	Session
next-auth.pkce.code_verifier	www.divvly.app	Stores PKCE (Proof Key for Code Exchange) code verifier for enhanced OAuth security. Protects against authorization code interception attacks.	Session

3.2. Preference Cookies

These cookies remember your settings to improve your experience.

Name	Provider	Purpose	Expiry
NEXT_LOCALE	www.divvly.app	Stores your language preferences. Allows us to display the website in your chosen language.	1 year

3.3. Statistics Cookies

These cookies help us understand how users interact with the website by collecting anonymous data.

Name	Provider	Purpose	Expiry
_ga	Google Analytics (divvly.app)	Main Google Analytics identifier. Used to distinguish users and sessions. Collects anonymous statistical data.	2 years
ga#	Google Analytics (divvly.app)	Identifier specific to our Google Analytics 4 property. Used to collect data about user behavior.	2 years

4. Consent Management – Cookiebot

We use **Cookiebot** to manage your cookie preferences.

4.1. Cookie Banner

On your first visit, we display a banner informing you about cookies. You can:

- **Accept all** – consent to all cookie categories
- **Reject optional** – accept only necessary cookies
- **Customize** – choose specific cookie categories

4.2. Changing Preferences

You can change your cookie preferences at any time by:

- Clicking the "Cookie settings" link in the website footer
- Re-displaying the cookie banner

5. Third-Party Cookies

5.1. Google Analytics

We use Google Analytics to analyze website traffic. Google may process data on servers in the USA based on Standard Contractual Clauses (SCC).

5.2. Cookiebot

Cookiebot stores information about your cookie consents.
